NOTICE IS HEREBY GIVEN that a public hearing will be held by the Board of Supervisors on **September 10, 2013 at 1:30 pm at the Board of Supervisors Chambers** (Suite #330 – Administration Building) Civic Center, San Rafael, California. The subject of the hearing will be the Final Supplement to the 2007 Countywide Plan Environmental Impact Report for the 2012 Draft Marin County Housing Element (Final SEIR), project merits of the 2012 Draft Marin County Housing Element, amendments to the Countywide Plan related to housing, Zoning Map amendments and Development Code amendments related to housing, definitions, and development. The recommended Board of Supervisors action will be to consider certification of the Final Supplement to the 2007 Countywide Plan Environmental Impact Report for the 2012 Draft Marin County Housing Element (Final SEIR) and adoption of the other documents.
